Terms and Responsibilities of Vendors:

- Vendor participation is at the sole discretion of Show Management.
- Vendors must be committed to the entire length of the Event. Vendor booths are expected to be staffed at all times. If you have been accepted to vend and you do not attend the event, your application fee is non-refundable.
- Food vendors will need to apply for a Food Service Permit from the Greenfield Health Department to be a vendor at the event.
- Vendor location is at the sole discretion of event management. Event Management reserves the right to change yearly location of vendors.
- All food vendors must supply a certificate of insurance. “Franklin County Agricultural Society” must be named as an additional insured.
- The Show is a rain or shine event and the venue is not climate controlled. Vendor refunds will not be given in the event of foul or cold weather.
- We will only be providing the space for setup. Organizations are responsible for providing their own tables, chairs, tents, etc.
- Absolutely no holes are to be made in the pavement.
- Vendors will be notified of site location the first week of April.
