FRANKLIN COUNTY FAIR POWER WHEELS DEMO DERBY RULES

- 1. This is supposed to be fun for kids, parents please let them have fun!
- 2. Parents or Guardians must either sign and bring the waiver form with them or sign a copy on site before the event in order for their kids to participate.
- 3. Judges can rule that children won't participate if there are modifications to the car more than those allowed as stated here.
- 4. Kids 3-8 years of age may participate. There will be two age groups 3-5 and 6-8 years old.
- 5. Derby is limited to 6- or 12-volt power wheels ONLY. No connecting multiple batteries together. (this makes the vehicle move too fast and makes it unsafe)
- 6. No added reinforcements.
- 7. All doors and tailgates must be strapped shut. No sharp edges. Use zip ties, duct tape, or other flexible products to make them stay shut.
- 8. Stock tires only. Tires may be taped, however no screws in tires, chains, etc. allowed.
- 9. Do NOT raise or lower the vehicle. All vehicles must be the original stock height.
- 10. Batteries must be secured and away from the child.
- 11. Decorative changes can be made to the vehicle to make it look like a derby car, however, there can be no reinforcement to the vehicle. Changes and additions can ONLY be decorative. (i.e. header pipes sticking up, painting the car, etc.)
- 12. Helmets are required. Bicycle helmets are acceptable.
- 13. Closed toe shoes or sneakers required. NO Sandals.
- 14. Drivers must have a seat belt on at all times.
- 15. No passengers.
- 16. Everyone must pre-register as all participants will receive a prize.
- 17. When choosing a Power Wheels for your child, please keep in mind these vehicles will be running into each other, like bumper cars or demolition derby cars.
- 18. The Power Wheels must be the kind that the child sits IN, not ON. **NO FOUR WHEELERS, TRACTORS, OR MOTORCYCLES.**
- 19. Everyone must pay gate admission to the fair.
- 20. Only one parent per driver will be allowed in the Pit Area.
