POWER WHEELS DEMO DERBY RULES

1. This is supposed to be fun for kids, parents please let them have fun!
2. Parents or Guardians must either sign and bring the waiver form with them or sign a copy on site before the event in order for their kids to participate.
3. Judges can rule that children won't participate if there are modifications to the car more than those allowed as stated here.
4. Kids 3-8 years of age may participate. There will be two age groups 3-5 and 6-8 years old.
5. Derby is limited to 6- or 12-volt power wheels ONLY. No connecting multiple batteries together. (this makes the vehicle move too fast and makes it unsafe)
6. No added reinforcements.
7. All doors and tailgates must be strapped shut. No sharp edges. Use zip ties, duct tape, or other flexible products to make them stay shut.
8. Stock tires only. Tires may be taped, however no screws in tires, chains, etc. allowed.
9. Do NOT raise or lower the vehicle. All vehicles must be the original stock height.
10. Batteries must be secured and away from the child.
11. Decorative changes can be made to the vehicle to make it look like a derby car, however, there can be no reinforcement to the vehicle. Changes and additions can ONLY be decorative. (i.e. header pipes sticking up, painting the car, etc.)
12. Helmets are required. Bicycle helmets are acceptable.
13. Closed toe shoes or sneakers required. NO Sandals.
14. Drivers must have a seat belt on at all times.
15. No passengers.
16. Everyone must pre-register as all participants will receive a prize.
17. When choosing a Power Wheels for your child, please keep in mind these vehicles will be running into each other, like bumper cars or demolition derby cars.
18. The Power Wheels must be the kind that the child sits IN, not ON. **NO FOUR WHEELERS, TRACTORS, OR MOTORCYCLES.**
19. Everyone must pay gate admission to the fair.
20. Only one parent per driver will be allowed in the Pit Area.

Release of Sponsor: The undersigned, being fully aware that participation in the demolition derby will expose him/ her to a substantial and serious risk of property damage and/or personal injury or death, hereby releases any and all sponsors from the liability of any and all property damage, personal injuries or other claims arising from the undersigned participation in the demolition derby including those that are known and unknown, foreseen and unforeseen, future and contingent.

Covenant Not to Sue: The undersigned covenants that the undersigned shall not now or at any time in the future, directly or indirectly, commence or prosecute any action, suit or other proceeding against the sponsors (or their officers, directors, members, agents or affiliates) concerning, arising out of, or related to the actions, causes of actions, claims and demands hereby waived, released or discharged by the undersigned.

Assurances: The undersigned has full power, authority, capacity and right without limitations to execute, deliver and perform this release.

Binding Effect: This release shall be binding upon the undersigned and the undersigned spouse, legal representatives, heirs, successors and assigns.
